Phil's Corner

As we move through the summer of 2023 the assault on our values and style of life here in the Piedmont Valley continues to accelerate. The town of Piedmont was incorporated through the efforts of many long-term residents who saw the threat of uncontrolled growth to our style of life. I believe adjacent developments voluntarily annexed into our community because they sought protection from the explosive growth to the south. Our policies of controlled growth, lower taxes, and common sense in government seemed much more attractive. Several other small developments on the west side of town were protected from the threat to the south by our incorporation and the residents indicated that they did not want to be part of our community. While they use our library, park, and drive and walk on our streets, they are unwilling to pay our small tax levy. That is their choice. When they choose to become part of our entity we will welcome them. In the interim their complaints bear little weight. Annexation is the traditional method where a city extends its boundaries to include those areas that are urbanized or in the process of urbanizing and are adjacent to and contiguous with the existing boundaries of a city. The State of South Dakota has recognized the reality of a city's need to annex by establishing the legal procedures for annexation in South Dakota Codified Law Chapter 9-4. A city exists to provide necessary services and political representation to its residents. Without timely and properly planned annexations, developing towns will be burdened with tax inequities, municipal service inefficiencies, political fragmentation, and a disorderly sprawling growth pattern. Benefits of the annexation include an equitable sharing of the local tax burden. People and businesses located just outside of a city often enjoy many of the services of the municipality without providing tax monies to support their costs. City parks, fire protection, libraries, postal access and building code enforcement are prime examples. The South Dakota Supreme Court in Smith V. City of Rapid City, 1981, reasoned that "the people and property owners of an area proposed for annexation have neither the moral nor legal right to stand aloof from the incorporated community of which they are de facto part, enjoying most of the benefits, but disclaiming their duty to participate in providing these services." 307N. W. 2d 598, 604 (S. D. 1981). Most of the residents of the proposed area have only recently moved to the Piedmont area and are arguing for their rights but ignoring their duties. As Author Daniel Klein said in his article about Adam Smith in the Independent Review, duties trump rights. Only one of the new residents did his duty by talking to local government about the area he was moving into. The rest seem to be part of the entitled populace that is moving into our community. The members of our city government are all part -timers who have been working their tails off to protect our people from opportunists looking to make some easy money.

The City of Piedmont was incorporated August 17, 2007

We started as the original 16 blocks of downtown and the properties bordering Sturgis road to the overpass.

With a few annexations done earlier, our biggest growth began about 2011 when we began receiving annexation requests from property owners that took us south down Sturgis road, ending where our City Limits are now at Midland Heights.

Piedmont takes pride in the continuity of the Board and Office. Because we have been here, we have the knowledge to know when and why things in the past have happened.

Meet your Board

Phil Anderson 2007- current

Phil Anderson is a fourth generation resident of Piedmont, his Family having resided in the Piedmont Valley for over 100 years. He is a founding member of the Piedmont American Legion and a Post, District and State Commander of the Legion. He is a 65 year member of Grace United Methodist Church, a life member of the Masons and forty-et eight, and a 35 year member of the BPOE (Elks) and Disabled American Veterans. I was a graduate of Sturgis High School (Class of 67) and Black Hills State University, did a stint in the US Army and worked as a Construction Foreman in Wyoming before returning to Piedmont in 1980. Me and my wife, Kim, have raised three boys in Piedmont, two of whom still live in the community. I was one of the organizers of the incorporation of Piedmont and has served as Chairman of the Board for all but two of those years of our towns existence as an incorporated entity.

Bruce Lutz 2023-current

I have been a Piedmont resident for 25 years. I care deeply for the Piedmont Community and the Valley. I have been self-employed for the last 15 years. I enjoy listening to people.

Jack Parks 2007-current

John L. (Jack) Parks, 74 years old. Black Hills native, has lived in Piedmont for fifty years, is married to Theresa Parks, and has two grown children, six grandchildren and one great grandson.

I served in the U.S. Army for three years as a surveyor, one of those in Viet Nam. I now belong to the American Legion and a life member of the DAV. After an honorable discharge, I then worked for engineering companies doing surveying and soil testing until 1988 at which time I started my own company, Fire Steel Forge. I specialized in traditional blacksmithing all around the Black Hills. I was on the Board of Directors of Artist Blacksmith's Association of North America and was Co-Chair of our biannual conference held in Rapid City in the middle of July 2012. Over 900 Blacksmiths from all over the world attend.

I like to Garden and raise fruit trees; I would like to have a few chickens. I like to fish, camp and enjoy the outdoors and Piedmont is a great place to do all that. Farmall Tractors is now my hobby.

I have served for fifteen years as the vice-chairman of the City Council. I am one of the original spark plugs that took the initiative to make Piedmont incorporated and I'm still very interested in keeping this community together. We succeeded in getting a first-class water system and are currently working on a sewer system for our geologically sensitive valley here. I also served on the Piedmont Park Board for many years before the city became incorporated and saw to its upkeep and was instrumental in starting the Library as well. I believe society is better off if the people are more self-sufficient, therefore I like to see small business, service organizations, Scouts, orchards, and gardens, and maybe even a few chickens. Piedmont citizens are very volunteer oriented, which I like to see. The Piedmont Valley Public Library is a prime example of that. Piedmont is growing by leaps and bounds and to accomplish what needs to be done, there needs to be controlled growth and conservation of the funds available. I feel that I can help that to happen. My engineering and business experiences help.

Phil Aitken 2019-current

My Family and I moved to the area in 2003 and into Piedmont in 2014. I run a Heating and Cooling Business.

Mike Lee 2020-current




