## Piedmont Board of Trustees

January 2, 2018 Unapproved Regular Meeting Minutes

- 1) The Meeting of the Piedmont Board of Trustees was called to order at 6:30 p.m. on Tuesday, January 2, 2018, beginning with the Pledge of Allegiance. In Attendance: Phil Anderson, Amy Bannister, Scott Toothman, Jack Parks & Bill Paris.
- **2)** Minutes: a) Bannister made **Motion, Seconded** by Toothman to approve the Minutes of the Regular Meeting on December 19, 2017. All voted "Aye". **Motion carried.** b) Paris made **Motion, Seconded** by Bannister to approve the Minutes of the Special Meeting on December 26, 2017. All voted "Aye". **Motion carried.**
- Water System: a) Dave Miller wanted to update the Board on the progress to hooking up to City water. He has Curtis at Patriot Plumbing working on the Trailer Park side and feels the Covered Wagon side is not cost effective unless other neighbors hook up also. Alternative was discussed in bringing the line back from where it crosses the road by Zweifels. Water restrictions were also discussed and explained that is watering yards, not household usage. Also discussed removing the trailer that just burned and bringing in a newer trailer, per City Ordinance, and put new one in an empty spot in trailer park. Anderson informed Mr. Miller that the number of trailers cannot exceed the number identified during the walk through. b) Lorne Kuper, from Black Hawk Water was present first apologizing for the water outage from a couple weeks ago and future plans to keep something like that from happening again by putting in a loop so shut offs can be easier and not affect the users down line. Kottwitz discussed that Zandstra is done using hydrant for Interstate work and that the Board should consider a rate increase if they wish to use it again.

- **7)** Street Maintenance: a) Kyle was out clearing sidewalks, doing a little plowing and putting down gravel on slick intersections.

All voted "Aye". **Motion carried.** c) Paris made **Motion** to go into Executive Session to discuss salaries, **Seconded** by Bannister.
