July 20, 2021 Unapproved Regular Meeting Minutes

- 1) The Meeting of the Piedmont Board of Trustees was called to order at 6:30 p.m. on Tuesday, July 20, 2021, beginning with the Pledge of Allegiance. In Attendance: Mike Lee, Phil Anderson, Kim Plymate, Phil Aitken & Jack Parks.
- **2)** Minutes: a) Aitken made **Motion** to approve the Minutes of the Regular Meeting on July 6, 2021, as written. **Seconded** by Parks. All voted "Aye". **Motion carried.**
- 3) Planning & Zoning: a) 1) Terry Nelson-replat. Planning & Zoning recommended approval. After discussion, Lee made **Motion** to approve the Preliminary and Final Plat, **Seconded** by Plymate. All voted "Aye". **Motion carried.** 2) Tom Gunderson-Engineer Plan. Planning & Zoning recommend sending plan to City Engineer to look over and approve. Discussion. Board is waiting to hear back from State.
- **4)** Library: a) Written Report. Friends of the Library 4<sup>th</sup> of July Booksale made \$1,900.00. Grant approved at the last meeting ran out of funds, so requesting to try for another Grant. Plymate made **Motion, Seconded** by Parks to apply for the other Grant. All voted "Aye". **Motion carried.**
- **5)** Park: a) Trees are being watered. Sprinkler system is not working but called to be repaired.
- 6) Street Maintenance: a) Chip seal will begin tomorrow (Wednesday the 21st.) Anderson asked Lee (who works for Simons) if it would do any good to run some of the Chip seal into the gravel area. Lee said it would be a waste of money. Stagebarn streets were deferred to Executive Session at the end of the meeting. b) Midland Heights request for 15 mph signs was discussed but needs to wait until Piedmont has an Ordinance with a fine schedule so that it could be enforceable.
