June 2, 2020 Unapproved Regular Meeting Minutes

- **2)** Minutes: a) Toothman made **Motion** to approve the Minutes of the Regular Meeting on May 19, 2020, **Seconded** by Parks. All voted "Aye". **Motion carried.**
- 3) Planning & Zoning: a) No Report
- **4)** Library: a) Report: Re-opened the doors for limited hours and new procedures. Summer Reading Program will be done virtually this year. Sneeze guard and Lights in the center isle were put up the other day.
- **5)** Park: a) Report: Trees are being watered and Park mowing being done. Have Weed & Feed to hopefully help with the dandelions.
- **6)** Street Maintenance: a) some Street repair being done.
- 7) Water: a) Written report was given. Trail West loss has dropped considerably. All Fire Hydrants have been flushed and Valves will be exercised within the next 30 days.

Parks **Seconded**. **Motion Carried.** Aitken made **Motion** to add Amendment that all Vendors must follow CDC Guidelines, **Seconded** by Anderson. Voted for the Amendment: Jack Parks Yay, Phil Anderson Yay, Phil Aitken Yay, Scott Toothman Nay and Steve Heilman Nay. 3 Yays and 2 Nays, **Motion carried.** Voting for Festivities and Vendors Phil Anderson Yay, Jack Parks Yay, Phil Aitken Yay, Scott Toothman Nay and Steve Heilman Nay. 3 Yay and 2 Nay **Motion carried.** The Board will support whatever the Library decided to do. f) Nuisance Ordinance discussion will happen next meeting.

- **13)** Executive Session: Toothman made **Motion, Seconded** by Parks to go into Executive Session after a 5 minute break. All voted "Aye". **Motion carried.** 8:07 p.m. / Anderson made **Motion, Seconded** by Toothman to come out of Executive Session. All voted "Aye". **Motion carried.**
