May 2, 2023 Unapproved Regular Meeting Minutes

- **1)** The Meeting of the Piedmont Board of Trustees was called to order at 6:30 p.m. on Tuesday, May 2, 2023, beginning with the Pledge of Allegiance. In Attendance: Phil Anderson, Jack Parks, Mike Lee & Phil Aitken.
- **2)** Minutes: Parks made **Motion** to approve the Minutes of the Regular Meeting on May 2, 2023, as corrected. **Seconded** by Aitken. All voted "Aye". **Motion carried.**
- **3)** David Brenneman from the Piedmont Valley Chamber of Commerce gave the Council a list of the trucks that will be attending the "Save the Piedmont Fireworks" event and will amend if there are any changes. Aitken made **Motion, Seconded** by Parks to allow the listed vendors to operate on Park Street on June 21st between the hours of 5:00 pm 8:00 pm. All voted "Aye". **Motion carried.**
- 4) Planning & Zoning: a) The missing Garage Building Permit is being requested again from Royer. ANCO turned in a Building Permit but they are not yet in the City, so it was retuned and told they have to go to the County. Discussed Liebig Preliminary Plat and Conditional Use. From our attorney we confirmed that we cannot do the Conditional Use Permit until the Plat is finalized because we don't have a legal address to use in the Conditional Use. But, before we can approve the Final of the Plat a road has to be built or a bond has to be put up. And when the Conditional Use is done it has to be done for only the portion of the property that the Trailer sales will be on.
- **5)** Library: a) Written report was in the packets. b) Lee made **Motion, Seconded** by Parks to allow 2nd Street in front of the Library and Park to be blocked off for the Library's Summer Reading Program Kick-off and Touch a Truck Event.
